LEGAL FRAMEWORK

- As per provision 17(3) of Plastic Waste Management Rules,2018 (as amended) State Pollution Control Board or Pollution Control Committee shall prepare and submit an annual report in Form VI to the CPCB on the implementation of PWM Rules.
- As per provision Rule 24.(3) of Solid Waste Management Rules, 2016, Each State Pollution Control Board or Pollution Control Committee as the case may be, shall prepare and submit the consolidated annual report to the Central Pollution Control Board and Ministry of Urban Development on the implementation of these rules and action taken against non complying local body by the 31stday of July of each year in Form-V.
- As per Schedule-II of PWM Rules (Guidelines on EPR for Plastic Packaging) " Centralized EPR Portal" is to be developed for registration of PIBOS and PWPs and compliance of EPR target for plastic packaging.
