² The committee will consider the complaints from women employees relating to sexual harassment. The word "Sexual Harassment" will include such unwelcome sexually determined behaviour, whether directly or otherwise such as:

- a) Physical contact and advances;
- b) Demand or request for sexual favours;
- c) Sexually coloured remarks;
- d) Showing any Pornography; or
- e) Any other unwelcome, Physical, verbal or Non-verbal conducts of sexual nature.
- 3. The committee will provide where necessary, a special counsellor or other support service including maintenance of confidentiality of the complaint and ensure time bound treatment and redressal of complaints made by women employees.
- 4. The guidelines of Supreme Court and DoPT issued vide DoPT OM dated 13.02.1998 in this regard are enclosed for the use of Members of the committee.
- 5. The committee will hear complaints from employees of the offices of NSO, DPD(HQ), Giridih, & SDRD, Kolkata.
- 6. As per DoPT OM No. 11013/3/2009-Estt.(A) dated 8th October 2009, the committee shall meet at least once in every quarter even if no live case is available, to review the preparedness and fulfil the requirements of the Apex Court's Judgement in Vishakha case, convenor of the committee will be responsible for appropriate action in this regard.
- 7. All complaints by the women employees against sexual harassment received in the Ministry shall be routed through the convener of the committee to maintain proper records of such complaints & their disposal.
