GSR. 760.—In exercise of the powers conferred by the powers to Article 309 of the Constitution and in supersession of the General Central Service (Cluss-III posts in the additial Statistics Wing, Central Statistical Organisation, Ideota, Cabinet Secretariut) Recruitment Rules, 1959, in a lar as they relate to the post of Assistant except as reseas things done or omitted to be done before such supersistant, the President bereby makes the following rules restaining the method of recruitment to the post of Assistant a the Central Statistical Organisation, (Industrial Statistics Wing), Calculta under the Department of Statistics, Ministry of Planning, namely :—

- f. Short-fille and commencement:—(1) These rules may be called the Central Statistical Organisation (Industrial Statistics Wing), Calcutta, (Assistants) Recruitment Rules, 1986.
- (2) They shall come into force on the date of their publication in the Official Gazette.

2. Number of post, classification and scale of pay:—The samer of the said post, its classification and the scale of py allached thereto shall be as specified in columns 2 to 4 with Schedule annexed to these rules.

3. Method of recruitment, age limit, qualifications, etc.:—
The method of recruitment, age limit, qualifications and other matters relating to the said post shall be as specified in columns 5 to 13 of the said Schedule.

4. Disqualification:—No person—

(a) who has entered into or contracted a marriage with a person having a spouse living, or

(b) who, having a spouse living, has entered into or contracted a marrigae with any person,

shall be eligible for appointment to the said post :

Provided that the Central Government may if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax:—Where the Central Government is of opinion that is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing relax any of the provisions of these rules with respect to any class or category of persons.

6. Savings:—Nothing in these rules shall affect reservations, relaxation of age limit and other concession required to be provided for the Scheduled Castes, the Schedule Tribes. Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
