The Ministry of Statistics and Programme Implementation vide notice of even number dated 24th February 2016 invited applications from eligible candidates pursuing post-graduation/research from recognized universities/institutes under the above mentioned scheme.

2. As per the notification, the objective of the scheme is to familiarize the interns with the Official Statistical System of the country, with a specific reference to data collection, processing & analysis, publication & dissemination.

3. List of selected candidates under the Internship Scheme 2016-17 vis-a-vis subject and Internship Center/Office allocated to them is appended at **Annex-I**

4. Selected candidate are **requested to confirm their acceptance and joining of internship in writing (email) to the undersigned latest by 11th May 2016**, along with a certificate in the format enclosed at **Annex-II** indicating that he/she has not attended the internship programme of this ministry earlier and will not attend any other such programme from any other institute/agency during the internship period. If **confirmation of joining the internship programme is not received by 11th May 2016 selection would stand cancelled** and the resultant available slot would be offered to the waitlisted candidates.

5. Selected candidates are requested to **report for Internship at the latest by 16th May 2016 to undergo internship** of two month's duration at the Internship Center/Office as indicated in the **Annex-I**, failing which his/her candidature would stand cancelled and available slot would be offered to the waitlisted candidates.

6. The selection for internship cannot and should not to be construed or interpreted as any kind of job or assurance for any job in the Government of India.

7. Interns shall be required to present a brief report/paper at the end of the internship.

8. Designated/Controlling officers of Internship Centre/Office would Guide, supervise and monitor the work of interns.

9. The interns will be provided with the minimum operational/ functional support such as office space, computer with internet facility etc. by the Internship Centers/Offices.

10. A certificate will be issued to interns by Designated/Controlling officer of internship Centre at the end of the successful completion of the internship.

11. A token scholarship of Rs. 10,000/- (consolidated) at the rate Rs. 5000/- per month for duration of internship i.e. for two months would be paid to interns by the Ministry of Statistics and Programme Implementation on successful completion of internship at the end of internship period. For this purpose interns would be required to submit a copy of certificate issued by the internship Centre and a copy of report/paper project report.

12. In case of any irregularity or misconduct is noticed on the part of any interns, the concerned internship Centre/Office will have to report the matter to the Ministry of Statistics and Programme Implementation for taking appropriate action.
