Complainants may, however, first approach the branch/bank concerned for redressal of complaints. If the grievance is not redressed by the branch/bank concerned within a period of 30 days (or) if he/she is not satisfied with the reply received from the branch/bank then he/she may, choose to approach the Office of the Banking Ombudsman (BO) of the region with full facts/details supported by documents, if any, relied upon by the complainant, at the following address:
