OFFICE MEMORANDUM

Sub: Parking arrangement for vehicles of officers/staff of NSCS/MoSPI/DAR&PG/ MoPR/ Cab.Sectt. at Patel Chowk Metro Station - reg.

The open parking space and all other available area on ground floor in SP Bhavan is being utilized for parking of official/hired/personal vehicles of all officers/staff working in the premises. Over a period of time, the parking space has become quite cramped. Most of the times it becomes extremely difficult even to find space for parking of vehicles of important dignitaries, foreign delegations and officers visiting the building for meetings etc. and they have to find parking space on the roadside which is also not permitted. This creates a very embarrassing situation for Government departments working in SP Bhavan. Also, the building is under repair and there is always a danger of malba falling over parked vehicles and damage them causing harm to property and injury to persons. In addition, the congestion of parking space also increases security threat.

- In view of above, various options of alternate parking spaces in the nearby areas were explored. After due diligence, it has been decided to hire DMRC parking at Patel Chowk Metro Station which is nearest among all available alternatives and is also being used by some other departments. The authorized DMRC contractor is ready to provide parking space for S.P. Bhawan vehicles with valid NSCS parking labels. The cost would be borne by NSCS.
- The following parking arrangements have been decided:

| (i) | Car | Vehicles of JS and above officers with escort, if any. | S.P. Bhawan |
| (ii) | -do- | Official/hired vehicles used by Departments placed in S.P. Bhawan for their official purposes. | S.P. Bhawan |
| (iii) | -do- | Private vehicles up to Director level officers and having NSCS parking label. | Patel Chowk Metro Station |
| (iv) | -do- | Vehicles of outside office/officers, dignitaries, delegations visiting the SP Bhawan for meetings. | S.P. Bhawan with specific temporary short-term parking label issued by CISF. |
| (v) | Motor- cycles | All motorcycles except official motorcycles belonging to Dispatch Riders. | Patel Chowk Metro Station |

Parking from 15.5.2019 will be strictly as per above scheme. The Patel Chowk Metro Parking will, however, start accepting NSCS labeled vehicles w.e.f. 13.5.2019 itself.
