Sir/Madam,

Please refer to your applications for internship under the Scheme for Internship for Post-graduates/Research Scholars 2017-18 of the Ministry of Statistics and Programme Implementation against notice of even number dated 28th February 2017.

2. List of selected candidates under the Internship Scheme 2017-18 vis-a-vis subject and Internship Center/Office allocated to them was published on 9th May 2017 on the website of the Ministry of Statistics and Programme Implementation.
3. Some of the selected candidates have intimated that they are not joining the internship. Therefore, you have been selected for undergoing internship against available vacant slots. Subject and Internship Center/Office allocated to you is at **Annex-I**
4. As per the notification, the objective of the scheme is to familiarize the interns with the Official Statistical System of the country, with a specific reference to data collection, processing & analysis, publication & dissemination.
5. You are requested to confirm acceptance and joining of internship in writing, through email as per format enclosed at **Annex-II**, to the undersigned **latest by 23rd May 2017**. If confirmation of joining the internship programme is not received by 23rd May 2017 selection would stand cancelled and the resultant available slot would be offered to the waitlisted candidates.
6. You are requested to report for Internship on or **before 25th May 2017** to undergo internship of two month's duration at the Internship Center/Office as indicated in the **Annex-I** failing which your candidature would stand cancelled and available slot would be offered to the waitlisted candidates. No Travelling Allowance or Dearness allowance will be paid by the Ministry for joining the place of internship allotted to you or after the completion of internship. You will have to make your own arrangements for lodging, boarding and transport etc.
7. The selection for internship cannot and should not to be construed or interpreted as any kind of job or assurance for any job in the Government of India.
8. Interns shall be required to present a brief report/paper at the end of the internship.

9. Designated/Controlling officers of Internship Centre/Office would Guide, supervise and monitor the work of interns.
10. The interns will be provided with the minimum operational/ functional support such as office space, computer with internet facility etc. by the Internship Centers/Offices. However, interns may have to bring their own laptop if situation demands so.
11. A certificate will be issued to interns by Designated/Controlling officer of internship Centre at the end of the successful completion of the internship.
12. A token stipend of Rs. 10,000/-(consolidated) @Rs.5000/- per month would be paid to the selected intern by the Ministry of Statistics and Programme Implementation on successful completion of internship at the end of internship period only through electronic mode of funds transfer/ Aadhaar Payments Bridge (APB)/Aadhaar Enabled Payment System (AEPS). For this purpose interns would be required to submit a copy of certificate issued by the internship Centre and a copy of report/project report to the undersigned. If any intern leaves or discontinues the internship scheme in between, that is, before completion of two months, he/she will not be entitled for any stipend & Certificate.
13. In case of any irregularity or misconduct is noticed on the part of any interns, the concerned internship Centre/Office will have to report the matter to the Ministry of Statistics and Programme Implementation for taking appropriate action.
