Dear *Chief Secretary,*

Kindly refer to our letters of even no dated 11th December 2018, 7th March, 2019 and 3rd May 2019 regarding conduct of the 7th Economic Census (EC) in 2019 for all economic establishments in the country. The EC is a very elaborate exercise and one of the outcomes are the listing of economic establishments is to form a National Statistical Business Register which would be useful for policy making and for informed decisions. Most of the State/ UTs have already constituted State and District level Coordination Committees to assist in the monitoring of the field work which is being undertaken by CSC e-Governance Services India Ltd under MEITY. It will be appreciated if these could be constituted quickly, in case not already done, as the field work is slated to start in June – July 2019 and be completed by September – October 2019.

2. In this direction an All India Training of Trainers was organized on 14th May 2019 and the State/ UT level workshops are being organized within the next 2-3 weeks which will be followed by District level workshops. The EC exercise is being undertaken under Collection of Statistics Act and the field work will be undertaken by CSC-SPV. The monitoring and supervision will be jointly done by Field Operations Division (FOD) of this Ministry and State/ UT Government officers.

3. As the proposed National Statistical Business Register can be used by all stakeholders, it is important that relevant standards and protocols be defined for its updation and for sharing information with the stakeholders. In this context, it will be appreciated if the Local Government (LG) Directory along with the corresponding census codes may be shared with the concerned FOD officers posted in your State (list attached). As this is a collaborative exercise, I

will appreciate if this information can be shared at the earliest and appropriate instructions issued to the concerned State Department for providing active cooperation in the monitoring and supervision work.
