**CIRCULAR**

A meeting was held in the Office of Chief Electoral Officer, Delhi on 18.09.2019 called for "Awareness on Electors Verification Programme (E.V.P.)". The meeting was Chaired by Chief Electoral Officer, Delhi. The following points were emphasized in the meeting :-


- (i) Electors details can be verified on the website; [www.nvsp.in/](http://www.nvsp.in/) [www.ceodelhi.com](http://www.ceodelhi.com) or by using Q.R. Codes with a Smartphone;
- (ii) The helpline No. Toll free in this regard is 1950;
- (iii) The electoral verification can be done through both on-line or off-line method; and
- (iv) The main intent of the programme is to have 100% error-free Electoral Roll and no voter is left behind.

2. After underlining the importance of E.V.P., the following instructions were given to all the participants from various Ministries/ Organisations attending the meeting :-

- (I) All categories of Personnel (including contractual and outsourced staff) in various Ministries/ Organisations are to verified their details by using one of the methods mentioned herein above;
- (II) The exercise of addition/ deletion, change of residence/ constituency, etc. have to be carried out for all categories of personnel viz. Contractual/ outsourced staff in the Ministry/ Organisation by using the relevant forms available on-line.
- (III) All Ministries/ Organisations should create a link for E.V.P. on the official website/ official facebook page and official whats-app and twitter handle;
- (IV) Wide publicity may be given by pasting the pamphlets near entry doors and other vantage points in the buildings of Ministries/ Organisations;

(V) E.V.P. in respect of all the personnel in a Ministry/ Organisation is to be completed by 25.09.2019 in the first stage. The second stage could be extended upto 30.09.2019 and a Certificate in this regard has to be provided by the Divisional Heads to the Nodal Officer on or before 25.09.2019;

3. In view of the instructions of the Chief Electoral Officer, Delhi as mentioned in para 2 above, all categories of personnel (including contractual and outsourced staff) are requested to co-operate in making the E.V.P. campaign by verifying their individual details as Elector success.
