### आदेश / ORDER

In continuation of MoSPI's Order of even number dated 07.08.2024 (Copy enclosed) regarding creation of two survey-wise verticals / divisions i.e. 'Household Survey Division (HSD)' and 'Enterprise Survey Division (EnSD)' in National Sample Survey (NSS), with the approval of Competent Authority, the following are decided:-

- (i) Data Processing Center (DPC), Kolkata which is currently part of EnSD (erstwhile DPD) to be subsumed into 'Household Survey Division (HSD)' and 'Enterprise Survey Division (EnSD)'. Accordingly, staff of DPC, Kolkata reallocated to HSD and EnSD.
- (ii) DPC, Nagpur and DPC, Bengaluru will function under the administrative control of Household Survey Division (HQ), Kolkata and designated as Household Survey Unit, Nagpur and Household Survey Unit, Bengaluru respectively.
- (iii) DPC, Delhi, DPC, Giridih and DPC, Ahmedabad will function under the administrative control of Enterprise Survey Division (HQ), Kolkata and designated as Enterprise Survey Unit, Delhi, Enterprise Survey Unit, Giridih and Enterprise Survey Unit, Ahmedabad respectively.
- (iv) Accordingly, the sanctioned strength of the officers belonging to both the Indian Statistical Service (ISS) and Subordinate Statistical Service (SSS) Cadre as per respective ISS Rules 2016 and SSS Rules 2013, posted in the erstwhile SDRD, DPD, IS Wing and DPCs have been reallocated as per Annexure I. The concerned ISS and SSS Divisions may issue separate posting orders as per revised allocation of posts.

#### आदेश / ORDER

In order to functionally re-organise National Sample Survey (NSS) from process-based to product-based ecosystem with the objective to ensure that survey methodologies are strengthened and NSS is able to release qualitative results/ reports in shortest possible time, it has been decided to create the following two survey wise verticals/ divisions in NSS to provide turnkey services with respect to a particular product/survey.

- a. Household Survey Division; and
- b. Enterprise Survey Division
- 2. Accordingly, the Survey Design and Research Division (SDRD) is redesignated as 'Household Survey Division (HSD)'. The Data Processing Division (DPD) and the Industrial Statistics (IS) Wing together are re-designated as 'Enterprise Survey Division (ESD)'. Each vertical i.e. 'Household Survey Division' and 'Enterprise Survey Division' will be headed by an ADG (HAG) level officer who will be reporting to DG (NSS).
- 3. The two divisions will continue to function as Sub-ordinate offices in NSS similar to their earlier status, with independent Head of Department (HoD), taking care of their administrative issues separately and non-overlapping of works/functions.
- 4. The existing sanctioned posts of ISS & SSS officers in the two divisions and Data Processing Centres (DPCs) will be redistributed and redeployed by the respective Cadres, as per the requirements of the divisions, in consultation with DG (NSS), and with the approval of Competent Authority. The entire process to be completed within four weeks of the issue of this order. Subsequently, both the reorganised divisions of NSS will start functioning as an independent division within a month.
- 5. The ministerial and non-ministerial staff existing in the Data Processing Division (including IS Wing) [re-designated as Enterprise Survey Division] and the Survey Design and Research Division [re-designated as Household Survey Division] will continue to function on 'as is where is' basis so that their inter-se seniority in their cadre is maintained.
- 6. Both the 'Household Survey Division (HSD)' and 'Enterprise Survey
