

#### <u>Order</u>

The issue of ad-hoc, case-to-case way of appointing HoDs in field/office units of CSO and NSSO has been considered in this Ministry. As a matter of due administrative and financial diligence and to adopt a regular, uniform system of decision-making, it has been decided:

- i. The HoD may be an officer of the level of DDG, to be proposed by the Divisional Head (ADG) and recommended by the DG concerned.
- ii. In case a DDG-level officer is not available (for whatsoever reason), the senior-most available Director/ DS-level officer may be so proposed/recommended.
- iii. The officer being considered should be clear from vigilance angle.
- iv. The nomination may be made by name and designation.
- v. On a proposal made as per (i) to (iv) above, the approval in the Ministry may be granted at the level of JS (Admin.).
