OFFICE MEMORANDUM

Subject: Roof Top Solar (RTS) Project in Ministry of Statistics & P.I. (MoSPI).

PM Surya Ghar: Muft Bijli Yojana (PMSG: MBY), launched by Govt. of India on 13.02.2024, aims to saturate roof-tops of govt. owned buildings with Solar Panels by end of 2025 with Ministry of New and Renewable Energy (MNRE) being the Nodal Ministry who had allocated Satluj Jal Vidyut Nigam Ltd. (SJVN), a CPSE, for this Ministry (MoSPI) to facilitate implementing the Roof Top Solar (RTS) project. Accordingly, one Ministry-level Nodal Officer and 4 (four) Sub-Nodal Officers from NSSTA (Attached Office), FOD and DPD/EnSD (Subordinate Offices) and ISI (Autonomous Institute) were nominated and data on site and building details were uploaded on the national portal: pmsuryaghar.gov.in

2. Vide D.O. Letter dated 27/09/2024 (copy enclosed), Secretary, MNRE had advised to complete the entire solarization project with the help of MNRE allocated SIP, i.e. SJVN Ltd. in case of MoSPI, or any other agency chosen by the Ministry within the target date of end of 2025.
3. Following this, FOD, a Sub-ordinate Office of MoSPI and the largest stakeholder, having offices all over the country, has opted for CPWD for this RTS Project.
4. SJVN Ltd. had submitted drafts of Memorandum of Understanding (MoU), Agreement for Process Management Consultancy (PMC) and Power Purchase Agreement (PPA) to this Ministry (MoSPI) and the same documents were forwarded to all the stakeholders of MoSPI for examination after which several points have been raised by the constituent offices with regard to technical, financial and future aspects on such documents.

5. Therefore, keeping in view the main objective of the RTS Project alongwith its deadline, it has been decided that all the 4 (four) offices of MoSPI, viz. NSSTA, FOD, DPD/EnSD and ISI may independently opt for any agency of their respective choice for facilitating the RTS Project at the earliest to complete the entire project by December, 2025.

4. This is being issued with the approval of the competent authority.
