**Subject: Nomination of the Nodal Officer of MoSPI for Roof Top Solar (RTS) Project in all buildings owned by Ministry of Statistics & P.I. including its Attached Offices, Subordinate Offices and Autonomous Body (Indian Statistical Institute).**

The undersigned is directed to refer to Secretary, Ministry of New and Renewable Energy (MNRE)'s D.O. Letter No. 318/5/2024-GCRT dated 11.05.2024 on the subject cited above and to say that Government of India has launched the **PM Surya Ghar: Muft BijliYojana** on 13.02.2024, which aims to popularize the adoption the adoption of Roof Top Solar (RTS) in the country. One of the critical component of the scheme is to undertake the **saturation of all Government buildings** under the administrative control of Central Ministries (including autonomous bodies, subordinate bodies, COSEs, etc.) with rooftop solar **latest by end 2025**. The Ministry of New and Renewable Energy (MNRE) is coordinating this effort on behalf of the Government of India. As approved by the Government, a **Steering Committee** headed by Cabinet Secretary will monitor the progress of the scheme, especially the saturation of Government buildings, and provide guidance for its successful implementation.

In this regard, MNRE has requested to nominate a senior officer as the Nodal Officer of the Ministry for the entire exercise, who would regularly track and monitor the status of rooftop solar installation in the various offices of MoPSI, coordinate with Satluj Jal Vidyut Nigam (SJVN) Limited, a Central Public Sector Undertaking (CPSU) that has been allocated by MNRE for facilitating installation of RTS Project of this Ministry and also would regularly update the national portal: **[pmsuryaghar.gov.in/](http://pmsuryaghar.gov.in/)**
