


**ORDER**

  - The CEC shall be responsible for all aspects and stages of the Consultants selection i.e. issuance of EOI, Evaluation of EOI, short-listing of Consultants, deciding terms of reference, issuance of RFP, Evaluation of Technical & Financial proposal, negotiations and final selection of the Consultants.
  - CEC will also identify the scope of work and the time frame for which the services of Consultants are to be availed of.
  - After receiving the recommendation of the CEC, the concerned Division will obtain the concurrence of IFD and competent approval and issue the orders for engagement of Consultants without referring the matter to Administration Division.
3. In case any post is vacant, the link officer concerned will be associated in the CEC.
4. This issues with the approval of the Competent Authority.
