- On the similar lines, the Offices of NSSO(FOD), NSSO(DPD), NSSO(SDRD), NSSTA, Computer Centre may also identify and declare the post equivalent to SO/SSO or below which deals with cadre management / transfer / posting / recruitment / promotion / vigilance matters / procurement / contracts / tender / financial matters as sensitive, under intimation to this Ministry.
- It has also been decided that the posts of HoD / HoO within the Main Ministry as well as its all constituents viz, NSSO(FOD), NSSO(DPD), NSSO(SDRD), NSSTA, Computer Centre are declared as sensitive, with
