The Assistants, who have already been granted 2<sup>nd</sup>/3<sup>rd</sup> financial up-gradations under ACPS/MACPS and already allowed to exercise their option under FR-22(1)(a)(i) to get their pay fixed either from the date of their financial up-gradations or from the date of their next increment, viz 1<sup>st</sup> july of the year, no further option of fixation of pay, would be available to them now on their regular promotion as per rules.
