**ORDER**

**Subject:** Encadrement of posts into the Indian Statistical Service (ISS).

With the approval of the Competent Authority it has decided to include the following posts into the appropriate grades of Indian Statistical Service (ISS) mentioned against each of them.

- (i) One vacant post of Deputy Director and one vacant post of Assistant Director (Stat) in the Mahalanobis National Crop Forecast Centre (MNCFC), D/o Agriculture & Cooperation, M/o Agriculture, New Delhi into the STS (PB-3/ Rs.15600-39100+GP Rs 6600/-), and JTS (PB-3/ Rs.15600-39100+GP Rs 5400/-) level of ISS respectively. These posts are from the existing sanctioned post of Deputy Director and Assistant Director (Stat) of MNFCF, M/o Agriculture.
- (ii) one vacant post of Deputy Director in the FIU-IND, Ministry of Finance, D/o Revenue, New Delhi into the STS (PB-3/ Rs.15600-39100+GP Rs 6600/-) level of ISS. This post is from the existing sanctioned post of Deputy Director of FIU-IND, Ministry of Finance, D/o Reveune.

2. The inclusion of above posts shall be subject to the following conditions:

- a) Hereafter, these posts shall be filled only by the ISS officers and not by any other service.
- b) The above posts, thus inducted into the Indian Statistical Service (ISS), shall be incorporated in the sanctioned strength of ISS.
- c) Ministry of Statistics and Programme Implementation, being the Cadre Controlling Authority of Indian Statistical Service, shall be responsible for filling up of existing vacancy and subsequent transfer / posting of incumbents etc. with regard to the above posts.
