**Subject: Permission for writing/publish a research article for ISS Officers -reg.**

The procedure for obtaining the permission for writing/publishing a research article by ISS Officers has been reviewed in the Ministry.

2. In order to encourage ISS officers to write/publish research articles, it has been decided that henceforth there shall be no requirement of prior sanction/approval to write/publish a research article subject to the followings condition:

- i. The officer(s) is/are not deriving any monetary benefit from it.
- ii. The article shall not be against Government policies and not be in violation of Rule 9 CCS (Conduct) Rules, 1964.
- iii. The article should be an occasional honorary literary and/or scientific work without detracting efficiency of an officer(s) in discharge of official duties.
- iv. The officer should declare that the views expressed by the author in the article, are his/her personal and not that of the Government of India.
- v. The officer should give prior intimation to office where s/he is posted.
