



OFFICE ORDER

The President is pleased to order that Sh Vishnu Kant Srivastava, Junior Administrative Grade (JAG) officers of the Indian Statistical Service (ISS) be promoted to the Senior Administrative Grade (SAG) on regular basis in the pay scale of Rs.37400-67000+ 10000(GP) notionally w.e.f 11.12.2009 (ie the date of promotion of his immediate junior) and actually from the date of assumption of charge of the post and until further orders.


2. On promotion, the inter-se seniority of Sh Vishnu Kant Srivastava in SAG of ISS is fixed between Sh Debashish Choudhary and Shri T. Baskaran in the order dated 11.12.2009 of this Ministry. On his regular promotion to the SAG of the ISS, Sh Vishnu Kant Srivastava, Director, Dte.of Data Mgmt.(Cus. & C.Excise) M/o Finance, is posted as Deputy Director General, NSSO (FOD) M/o Stat. & PI, Meghalaya Region, Shillong vice Sh D.K Banerjee. With this, Sh Srivastava has been adjusted against the regular strength of SAG of ISS.

It is requested that immediate action may be taken under intimation to the Ministry of Statistics & Programme Implementation for the release of the officer promoted/transferred to enable him to assume charge of the new assignments at the earliest, after availing of joining time/TTA, etc. as admissible under rules.
