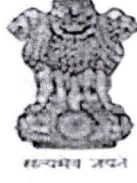

2. The committee shall hold office as per terms and conditions appended below: -


- I. The Presiding Officer and every member of the Internal Complaints Committee shall hold office for such period, not exceeding three years or till further orders from the date of issue of this OM, whichever is earlier.
- II. The member nominated from the NGO (Srl. 4 above) shall be paid such fees or allowances for holding proceedings of ICC as may be prescribed, as and when required. Presiding Officers and members a Srl. 1 to 3 above shall not be entitled for any remunerations for attending the proceedings of ICC.
- III. If the Presiding Officer or any Member of Internal Committee contravenes the provisions of Section 5 (a) to (d) and Section 16 of The Sexual Harassment of Women

3/11/09/2023

at Workplace (Prevention, Prohibition and Redressal) Act 2013 (No 14 of 2013), such Presiding Officer or Members, as the case may be, shall be removed from the Committee and the vacancy so created or any casual vacancy shall be filled by fresh nomination in accordance with the provision of Section 4 of the Act.

3. This shall come into force immediately from the date of issue of this OM.


