**भारत में वेतन पत्रक रिपोर्टिंग: एक रोजगार परिप्रेक्ष्य - अक्टूबर, 2023**

**परिचय**

1. अप्रैल, 2018 से यह मंत्रालय सितंबर, 2017 के बाद की अवधि को शामिल करते हुए औपचारिक क्षेत्र में रोजगार से संबंधित आंकड़े प्रकाशित कर रहा है, जिसमें तीन प्रमुख योजनाओं, अर्थात् कर्मचारी भविष्य निधि (ईपीएफ) योजना, कर्मचारी राज्य बीमा (ESI) योजना और राष्ट्रीय पेंशन योजना (NPS) के तहत सदस्यता लेने वाले सब्सक्राइबर्स की संख्या की जानकारी का उपयोग किया गया है।

2. सब्सक्राइबर की संख्या विभिन्न स्रोतों से प्राप्त होती है और इसमें अतिव्यापन के तत्व होते हैं। इसलिए, विभिन्न स्रोतों से प्राप्त अनुमान योगात्मक नहीं हैं। सितंबर, 2017 से अक्टूबर, 2023 की अवधि के लिए विस्तृत जानकारी अलग से संबंधित संगठनात्मक वेबसाइटों पर प्रकाशित की गई है। यह जानकारी सब्सक्राइबर की संख्या पर आधारित है और तालिकाएं अवधि के सात समूहों के लिए एक गतिशील स्थिति दर्शाती हैं - (ए) सितंबर 2017 - मार्च 2018, (बी) अप्रैल 2018 - मार्च 2019, (सी) अप्रैल 2019 - मार्च 2020, (डी) अप्रैल 2020 - मार्च 2021, (ई) अप्रैल 2021 - मार्च 2022 (एफ) अप्रैल 2022 - मार्च 2023 और (जी) अप्रैल 2023 से मासिक डेटा। भाग 2.1 में नए सदस्यों की संख्या जिन्होंने ईपीएफ की सदस्यता शुरू कर दी है, सदस्यों की संख्या जिन्होंने अपनी सदस्यता समाप्त कर दी है पर अब पुनः अंशदान दे रहे हैं की डेटा में लिंग-वार जानकारी शामिल है और उन सदस्यों की संख्या जिन्होंने पूर्व में सदस्यता समाप्त कर दी है। भाग 2.2 में डेटा में ईएसआई के संबंध में, अंशदान देने वाले मौजूदा कर्मचारियों की संख्या और अवधि के दौरान अंशदान देने वाले नए पंजीकृत कर्मचारियों की संख्या के संबंध में लिंग-वार जानकारी शामिल है। भाग 2.3 के डेटा में एनपीएस के संबंध में, मौजूदा सब्सक्राइबर्स और अवधि के दौरान अंशदान करने वाले नए सब्सक्राइबर्स के बारे में लिंग-वार जानकारी शामिल है।

## एंनोट: कवरेज और डेटा के स्रोत

1. कर्मचारी भविष्य निधि (ईपीएफ) **कर्मचारी भविष्य निधि और विविध प्रावधान अधिनियम, 1952 के तहत एक अनिवार्य बचत योजना है**। इसे कर्मचारी भविष्य निधि संगठन (ईपीएफओ) के तत्वावधान में प्रबंधित किया जाता है। अधिनियम में प्रदान की गई निश्चित शर्तों और छूट के अधीन यह प्रत्येक प्रतिष्ठान को शामिल करता है जिसमें 20 या अधिक व्यक्ति कार्यरत हैं (और कुछ अन्य प्रतिष्ठान जिन्हें केंद्र सरकार द्वारा अधिसूचित किया जा सकता है, भले ही वे 20 से कम व्यक्तियों को रोजगार देते हों), वेतन सीमा 15000/- रुपये प्रति माह है। रुपये 15000/- से ऊपर का वेतन आहरित करने वाले व्यक्ति को छूट दी गई है या कुछ अनुमति के साथ या स्वैच्छिक आधार पर नामांकित किया जा सकता है। इस योजना को सब्सक्राइब करने वाले सदस्यों की संख्या औपचारिक क्षेत्र में रोजगार के स्तर का अंदाजा देती है। सब्सक्राइबर्स-नए सदस्यों, बाहर निकलने वाले सदस्यों और सब्सक्राइबर्स जिन्होंने अपना सब्सक्रिप्शन फिर से शुरू किया है, का डेटा ईपीएफओ से प्राप्त किया जाता है। अधिक जानकारी <https://www.epfindia.gov.in> पर उपलब्ध है।
2. **कर्मचारी राज्य बीमा अधिनियम, 1948** गैर-मौसमी, विनिर्माण प्रतिष्ठानों (खान अधिनियम, 1952 (1952 का 35) के अधीन संचालित खान के अलावा, या एक रेलवे रनिंग शेड) पर लागू होता है, जिसमें 10 या उससे अधिक कर्मचारी काम करते हैं। स्वास्थ्य और चिकित्सा संस्थानों के लिए, सीमा 20 या उससे अधिक कर्मचारी हैं। भारत के लिए ईएसआई योजना एक एकीकृत सामाजिक सुरक्षा योजना है, जो संगठित क्षेत्र के श्रमिकों और उनके आश्रितों को बीमारी, मातृत्व और मृत्यु या नौकरी के दौरान चोट या व्यावसायिक जोखिम के कारण विकलांगता जैसी आकस्मिकताओं में सामाजिक-आर्थिक सुरक्षा प्रदान करने के लिए तैयार की गयी है। वेतन सीमा 21000/- रुपये प्रति माह है। सब्सक्राइबर्स को बीमित व्यक्ति (आईपी) कहा जाता है और रोजगार में बदलाव के कारण एक नया आईपी नंबर भी मिल सकता है। 21000/- रुपये प्रति माह की वैधानिक सीमा से अधिक वेतन या इस्तीफे, मृत्यु, सेवानिवृत्ति या बर्खास्तगी के कारण कर्मचारी अंशदान का भुगतान करना बंद कर सकते हैं। इस योजना के सब्सक्राइबर्स की संख्या भी औपचारिक क्षेत्र में रोजगार के स्तर का अंदाजा देती है। डेटा कर्मचारी राज्य बीमा निगम (ईएसआईसी) से प्राप्त किया गया है और जानकारी में ईपीएफ डेटा का दोहराव हो सकता है और इस प्रकार यह योगात्मक नहीं है। अधिक जानकारी <https://www.esic.nic.in> पर उपलब्ध है।
3. **पेंशन निधि विनियामक और विकास प्राधिकरण (पीएफआरडीए)** की राष्ट्रीय पेंशन योजना (एनपीएस) एक आसानी से सुलभ, कम लागत, कर-कुशल, लचीला और पोर्टेबल सेवानिवृत्ति खाता है। सरकारी क्षेत्र के लिए एनपीएस योजनाओं के तहत व्यक्ति अपने सेवानिवृत्ति खाते में योगदान देता है और साथ ही उसका नियोक्ता व्यक्ति की सामाजिक सुरक्षा/कल्याण के लिए सह-अंशदान करेगा। एनपीएस परिभाषित अंशदान के आधार पर तैयार किया गया है जिसमें सब्सक्राइबर अपने खाते में योगदान देता है, और संचित धन किए गए अंशदान और इस तरह के धन के निवेश से सृजित आय पर निर्भर करता है। 1 जनवरी 2004 से केंद्र और राज्य सरकारों ने सशस्त्र बलों को छोड़कर नए कर्मचारियों के लिए इस योजना को अपना लिया है।<sup>1</sup> केंद्र सरकार द्वारा एनपीएस को अपनाने के बाद अधिकांश राज्य सरकारों ने भी एनपीएस को अपनाया। एनपीएस को 2009 के बाद से कॉर्पोरेट क्षेत्र तक बढ़ा दिया गया था और यह कॉर्पोरेट को अपने सब्सक्राइबर्स के एनपीएस खातों में सह-अंशदान करने या उन्हें अपने एनपीएस खातों के लिए अपना स्वयं का अंशदान करने की सुविधा प्रदान करने के लिए मंच प्रदान करता है। अंशदान के तीन रूप हैं यथा केवल नियोक्ता से, केवल कर्मचारी से और नियोक्ता और कर्मचारी दोनों से अंशदान। अधिक जानकारी <https://www.pfrda.org.in> पर उपलब्ध है।
