PRESS NOTE

Subject: Quick Estimates of Index of Industrial Production and Use-based Index (Base 1993-94=100) for the month of October, 2010.

The Quick Estimates of Index of Industrial Production (IIP) with base 1993-94 for the month of October 2010 have been released by the Central Statistics Office of the Ministry of Statistics and Programme Implementation. The General Index stands at 331.5, which is 10.8% higher as compared to the level in the month of October 2009. The cumulative growth for the period April- October, 2010-11 stands at 10.3% over the corresponding period of the previous year.

2. The Indices of Industrial Production for the Mining, Manufacturing and Electricity sectors for the month of October 2010 stand at 203.5, 357.4, and 261.5 respectively, with the corresponding growth rates of 6.5%, 11.3% and 8.8% as compared to October 2009. The cumulative growth during April- October, 2010-11 over the corresponding period of 2009-10 in these three sectors have been 8.3%, 11.0% and 4.6% respectively, which moved the overall growth in the General Index to 10.3%.
3. In terms of industries, as many as fifteen (15) out of the seventeen (17) industry groups (as per 2-digit NIC-1987) have shown positive growth during the month of October 2010 as compared to the corresponding month of the previous year. The industry group 'Transport Equipment and Parts' have shown the highest growth of 39.5%, followed by 26.0% in 'Leather and Leather & Fur Products' and 24.6% in 'Other Manufacturing Industries'. On the other hand, the industry group 'Wood and Wood Products; Furniture and Fixtures' have shown a negative growth of 25.7% followed by 0.5% in 'Jute and other vegetable fibre Textiles (except cotton)'.
4. As per Use-based classification, the Sectoral growth rates in October 2010 over October 2009 are 7.7% in Basic goods, 22.0% in Capital goods and 9.5% in Intermediate goods. The Consumer durables and Consumer non-durables have recorded growth of 31.0% and 0.1% respectively, with the overall growth in Consumer goods being 9.6%.
5. During the current month, high growth has been observed in Capital goods and Consumer durable goods. High growth registered in Capital goods is to a large extent

attributed to 'Well/off shore platforms' [76.4%], 'Ship building and repair'[75.2%], 'Control panels/boards/disks'[69.9%], 'Laboratory and scientific instruments'[57.85%], 'Electric generators (including alternators)'[53.7%] and 'Turbines (steam/hydro)'[47.3%]. Similarly, high growth in Consumer durable goods is due to high growths in 'Scooter and mopeds'[77.5%], 'Alarm time pieces'[47.2%], 'Motor cycles'[44.2%], 'T.V. receivers'[33.4%] and 'Passenger cars'[30.8%].

6. Alongwith the Quick Estimates of IIP for October 2010, the indices for September 2010 have undergone the first revision and those for July 2010 have undergone the second (final) revision in the light of the updated data received from the source agencies. *(It may be noted that revised indices (first revision) in respect of August 2010 have already been released in September 2010 and these indices shall undergo final (second) revision in IIP for the month of November 2010).*
7. Statements giving Quick Estimates of the Index of Industrial Production at Sectoral, 2-digit level of National Industrial Classification (NIC)-1987 and by Use-based classification for the month of October 2010, along with the growth rates over the corresponding month of previous year, including the cumulative indices and growth rates, are enclosed.
8. Due to release of the new series of Wholesale price Index (WPI) with 2004-05 base by the Office of Economic Adviser, Ministry of Commerce & Industry, the indices from April'08 onwards and the growth rates from April'09 onwards were recompiled and released in the Press Note of previous month. On the request of the users of IIP data, indices from April'04 onwards have been recompiled at aggregate level and using Sectoral and Use-based classification. These are now being released in Statement-IV and Statement-V.
