PRESS NOTE

Subject: Quick Estimates of Index of Industrial Production and Use-based Index (Base 1993-94=100) for the month of August, 2010.

The Quick Estimates of Index of Industrial Production (IIP) with base 1993-94 for the month of August 2010 have been released by the Central Statistics Office of the Ministry of Statistics and Programme Implementation. The General Index stands at 309.1, which is 5.6% higher as compared to the level in the month of August 2009. The cumulative growth for the period April-August 2010-11 stands at 10.6% over the corresponding period of the previous year.

2. The Indices of Industrial Production for the Mining, Manufacturing and Electricity sectors for the month of August 2010 stand at 190.6, 332.6, and 247.6 respectively, with the corresponding growth rates of 7.0%, 5.9% and 1.0% as compared to August 2009. The cumulative growth during April-August 2010-11 over the corresponding period of 2009-10 in the three sectors have been 9.4%, 11.3% and 4.3% respectively, which moved the overall growth in the General Index to 10.6%.

3. In terms of industries, as many as fourteen (14) out of the seventeen (17) industry groups (as per 2-digit NIC-1987) have shown positive growth during the month of August 2010 as compared to the corresponding month of the previous year. The industry group 'Metal Products and Parts, except Machinery and Equipment' have shown the highest growth of 33.4%, followed by 27.9% in 'Other Manufacturing Industries' and 22.8% in 'Transport Equipment and Parts'. On the other hand, the industry group 'Wood and Wood Products; Furniture and Fixtures' have shown a negative growth of 15.3% followed by 3.0% in 'Textile Products (including Wearing Apparel)'.

4. As per Use-based classification, the Sectoral growth rates in August 2010 over August 2009 are 3.7% in Basic goods, (-) 2.6% in Capital goods and 10.0% in Intermediate goods. The Consumer durables and Consumer non-durables have recorded growth of 26.5% and (-) 1.2% respectively, with the overall growth in Consumer goods being 6.9%.

5. Alongwith the Quick Estimates of IIP for August 2010, the indices for July 2010 have undergone the first revision and those for May 2010 have undergone the second (final) revision in the light of the updated data received from the source agencies. *(It may be noted that revised indices (first revision) in respect of June 2010 have already been released in September 2010 and these indices shall undergo final (second) revision in November 2010).*

6. Statements giving Quick Estimates of the Index of Industrial Production at Sectoral, 2-digit level of National Industrial Classification (NIC)-1987 and by Use-based classification for the month of August 2010, along with the growth rates over the corresponding month of previous year, including the cumulative indices and growth rates, are enclosed.
