The Ministry released Price Movement of Sub-Groups/Groups of Consumer Price Index (CPI) on **Base 2012=100** for All India Rural, Urban, Combined for the month of **August, 2024** (Provisional) and for the month of **July, 2024** (Final) on **12<sup>th</sup> September, 2024**. The General Consumer Price Indices (CPI) for the month of **August, 2024** (Provisional) for Rural, Urban and Combined sector were 195.4, 190.3 and 193.0 showing an annual inflation rate of 4.16%, 3.14%, 3.65% respectively. The corresponding inflation rates (Final) for Rural, Urban and Combined sector for the month of **July, 2024** were 4.10%, 3.03% and 3.60% respectively.
2. All-India Consumer Food Price Index (CFPI) for the month of **August, 2024** (Provisional) for Rural, Urban and Combined sector were 200.8, 208.1 and 203.4 respectively. All India year-on-year inflation rates for CFPI for the month of **August, 2024** (Provisional) for Rural, Urban and Combined sector were 6.02%, 4.99% and 5.66% respectively. The corresponding inflation rates (Final) for Rural, Urban and Combined sector for the month of **July, 2024** were 5.89%, 4.63% and 5.42% respectively.
3. The All-India Index of Industrial Production (IIP) for the month of **July, 2024** (Quick Estimates) with the base year 2011-12 was released on **12<sup>th</sup> September, 2024** and it stood at 149.6.
4. 28<sup>th</sup> Conference of Central and State Statistical Organizations (COCSSO) was organized on 12<sup>th</sup> -13<sup>th</sup> August, 2024 at Dr. Ambedkar International Centre, 15 Janpath, New Delhi. Representatives from the Central Government and State/UT Governments participated in the conference. It was attended by representatives of more than 30 Central Ministries/Departments, around 29 State/UT Governments, Organizations/Institutions such as Reserve Bank of India (RBI), Indian Statistical Institute (ISI), Council of Scientific and Industrial Research (CSIR), Indian Agricultural Statistics Research Institute (IASRI), Indian Council of Agricultural Research (ICAR), PHD Chamber of Commerce & Industry (PHDCCI), International organisations such as World Bank, UN agencies and other stakeholders.
5. On 16<sup>th</sup> August, 2024 the roles and responsibilities of Statistical Advisers were formalized to strengthen statistical coordination of ministries with the Ministry of Statistics and Programme Implementation. The first workshop on sensitization cum feedback of Statistical Advisers was organized on 29<sup>th</sup> August, 2024 at New Delhi. The Workshop was attended by Statistical Advisers/ representatives of Central Ministries/Departments.
6. Ministry undertook the work related to setting up of milestones for SDG national indicators in consultation with the line Ministries. In this context, "Review of Milestone Setting for SDGs National Indicators" was organized at Vigyan Bhawan in New Delhi on 16<sup>th</sup> August, 2024.
7. To enhance MoSPI's interaction and engagement with data users/stakeholders for feedback, a one-day data user conference on the results of the All India Survey of Unincorporated sector Enterprises (ASUSE) 2021-22 and ASUSE 2022-23, was
