

## Major initiatives and achievements of the Ministry of Statistics & Programme Implementation for the month of July 2024.

The Ministry released Price Movement of Sub-Groups/Groups of Consumer Price Index (CPI) on **Base 2012=100** for All India Rural, Urban, Combined for the month of **July, 2024** (Provisional) and for the month of **June, 2024** (Final) on **12<sup>th</sup> August, 2024**. The General Consumer Price Indices (CPI) for the month of **July, 2024** (Provisional) for Rural, Urban and Combined sector were 195.3, 190.2 and 192.9, showing an annual inflation rate of 4.10%, 2.98%, 3.54% respectively. The corresponding inflation rates (Final) for Rural, Urban and Combined sector for the month of **June, 2024** were 5.66%, 4.39% and 5.08% respectively.

2. All-India Consumer Food Price Index (CFPI) for the month of **July, 2024** (Provisional) for Rural, Urban and Combined sector were 201.3, 210.0 and 204.3 respectively. All India year-on-year inflation rates for CFPI for the month of **July, 2024** (Provisional) for Rural, Urban and Combined sector were 5.89%, 4.63% and 5.42% respectively. The corresponding inflation rates (Final) for Rural, Urban and Combined sector for the month of **June, 2024** were 9.15%, 9.60% and 9.36% respectively.

3. The All-India Index of Industrial Production (IIP) for the month of **June, 2024** (Quick Estimates) with the base year 2011-12 was released on **12<sup>th</sup> August, 2024** and it stood at 150.0 against 143.9 in **June 2023**.

4. The Ministry has released following Report/Press Note during the month:

- i. Annual Survey of Unincorporated Sector Enterprises (ASUSE) Report for the year 2021-22 and 2022-23 on 5th July, 2024.

5. As per the latest Flash Report for the ongoing Central Sector Projects costing Rs. 150 crores and above of **July 2024**, following were the highlights:

As per the latest Review Report on the Performance of the Infrastructure Sectors, the positive growth rate has been observed in April-June FY 24-25 over corresponding month of FY 23-24 across pertinent parameters viz. [Power]- Power Generation (+10.85%), [Coal]- Coal including lignite Production (+11.33%), [Steel]- Production of Finished Steel (+4.36%), [Cement]- Cement Production (+0.98%), [Fertilizers]- Nitrogen, Phosphate and Urea Production (+1.2%), [Petroleum and Natural Gas]- Crude Oil Processed (+1.72%) & Natural Gas Production (+5.75%), [Roads]- Upgradation of Highways by State PWD & Border Road

Organization (BRO) (+5.39%), [Railways]- Passenger Traffic handled (+4.57%) & Revenue earning Freight Traffic (+5.01%), [Shipping]- Total Cargo handled at Major Ports (+3.89%), [Shipping]- Coal handled at Major Ports (0.84%), [Civil Aviation]- International Passenger traffic handled (+14.17%) & Domestic Passenger traffic handled (+5.56%), [Civil Aviation]- Export Cargo handled at Airports (+15.47%). However, negative growth has been observed across a few parameters viz. [Petroleum & Natural Gas]- Crude Oil Production (-0.73%), [Roads] Upgradation of Highways by NHAI (-7.93%), and [Telecom] Towers including Base Transceiver Stations (-84.57%).

7. The Ministry has initiated the process of research and data analytics of official statistics on matters of national importance and, sharing our findings with Ministries/Departments, which can be used as inputs for policy making. In this regard, a working paper on 'How to Enhance Labour Force Participation Women Rate in India-Evidence-based Policy Suggestions' as prepared by Ministry has been shared with 8 concerned Ministries on July 12, 2024.
