## Major initiatives and achievements of the Ministry of Statistics & Programme Implementation during September 2019

On the Statistics side, the Ministry has released monthly Index of Industrial Production (IIP) and the Consumer Price Index (CPI). The salient features of these are:

 As per the Quick Estimates (QE) of Index of Industrial Production (IIP) with base year 2011-12 released on 12<sup>th</sup> September 2019, the general index for the month of July 2019 stood at 131.1, which is 4.3% higher as compared to the level in the corresponding month of previous year.

 Field work of 7<sup>th</sup> Economic Census has been launched in 19 States/UTs so far. Field work in remaining States/UTs will be

launched shortly.

- The General Consumer Price Indices (CPI) with base year 2012 for the month of August 2019 (provisional) for Rural, Urban and Combined showed an annual inflation rate of 2.18%, 4.49% and 3.21% respectively. The Consumer Food Price Indices (CFPI) for August 2019 (provisional) for Rural, Urban and Combined showed an annual inflation rate of 0.85%, 7.07% and 2.99% respectively.
- 2. The data entry software developed by DQAD based on the World Bank CAPI Solutions for Annual Survey of Unincorporated Sector Enterprises used in the field work to begin from 1<sup>st</sup> September 2019 across India.
- 3. Monitoring of the infrastructure sector highlighted the following:

- As per the latest Review Report on the Performance of the Infrastructure Sectors for the month of July 2019, Power Generation (+9.88%), and Goods traffic carried by Railways (+0.65%), exceeded their targets.
- The Sectors that fell short of their targets are Coal Production (-12.45%), Fertilizers Production (-17.29%), Crude Oil Production (-3.48%), Refinery Production (-0.94%), Natural Gas Production (-5.06%), Upgradation of Highways by NHAI (-8.42%), Upgradation of Highways by State PWD & Border Road Organisation (BRO) (-2.02%) Export Cargo handled at Airports (-3.56%), Import Cargo handled at Airports (-16.14%), Passenger traffic handled at International terminal of the Airports (-6.06%) and Passenger traffic handled at Domestic terminal of the Airports (-10.13%).
- 4. Under MPLADS, an amount of ₹462.50 crore have been released during the Month of September 2019 and the total fund released during the financial year 2019-20 up to 30<sup>th</sup> September 2019 is ₹1542.50 crore.
