Major initiatives and achievements of the Ministry of Statistics & Programme Implementation during November 2019

On the Statistics side, the Ministry has released monthly Index of Industrial Production (IIP) and the Consumer Price Index (CPI). The salient features of these are:

- As per the Quick Estimates (QE) of Index of Industrial Production (IIP) with base year 2011-12 released on 11th November 2019, the general index for the month of September 2019 stood at 123.3, which is 4.3% lower as compared to the level in the corresponding month of previous year.
- Field work of 7th Economic Census has been launched in 3 States/UTs during November 2019, taking the total tally to 24 States/UTs so far. Field work in remaining States/UTs will be launched shortly.
- The General Consumer Price Indices (CPI) with base year 2012 for the month of October 2019 (provisional) for Rural, Urban and Combined showed an annual inflation rate of 4.29%, 5.11% and 4.62% respectively. The Consumer Food Price Indices (CFPI) for October 2019 (provisional) for Rural, Urban and Combined showed an annual inflation rate of 6.42%, 10.47% and 7.89% respectively.
- 2. The 27th Conference of Central and State Statistical Organization (COCSSO) held on 11th November 2019 at Kolkata, West Bengal was inaugurated by Prof. Bimal K Roy, Chariman, National Statistical Commission in the presence of Shri Pravin Srivastav, Cheif Statistician of India-cum-Secretary, MoSPI, Dr. G.C. Manna, Member, NSC, Shri Vijay Kumar, Director General (Survey). Representatives from Central Government Ministries, State Governments, International Agencies, Academic Institutions, Corporate Sector and other stakeholders participated in the conference to discuss statistical matters of interest.

 As per the latest Review Report on the Performance of the Infrastructure Sectors for the month of September 2019, Power Generation (+8.35%) and Upgradation of Highways by State PWD & Border Road Organisation (BRO) (+10.27%) exceeded their targets.

The Sectors that fell short of their targets are Coal Production (-16.79%), Fertilizers Production (-16.71%), Crude Oil Production (-4.52%), Refinery Production (-0.73%), Natural Gas Production (-6.03%), Upgradation of Highways by NHAI (-5.56%), Goods traffic carried by Railways (-3.46%), Export Cargo handled at Airports (-5.60%), Import Cargo handled at Airports (-16.61%), Passenger traffic handled at International terminal of the Airports (-5.73%) and Passenger traffic handled at Domestic terminal of the Airports (-9.54%).

4. Under MPLADS, an amount of ₹ 402.50 crore have been released during the Month of November 2019 and the total fund released during the financial year 2019-20 up to 30th November 2019 is ₹ 2442.50 crore.
