Major initiatives and achievements of the Ministry of Statistics & Programme Implementation during September, 2022

The National Statistical Office (NSO) released Price Movement of Sub-Groups/Groups of Consumer Price Index (CPI) on **Base 2012=100** for All India Rural, Urban, Combined sector for the month of **September**, **2022** (Provisional) and for the month of **August**, **2022** (Final) on 12th October, 2022. The General Consumer Price Indices (CPI) for the month of **September**, **2022** (Provisional) for Rural, Urban and Combined sector were 176.4, 174.1 and 175.3, showing an annual inflation rate of 7.56%, 7.27% and 7.41% respectively. The corresponding inflation rates (Final) for Rural, Urban and Combined sector for the month of **August**, **2022** were 7.15%, 6.72% and 7.00% respectively.

- 2. All-India Consumer Food Price Index (CFPI) for the month of **September**, 2022 (**Provisional**) for Rural, Urban and Combined were 174.4, 180.8 and 176.7 respectively. All India year-on-year inflation rates for CFPI for the month of **September**, 2022 (**Provisional**) for Rural, Urban and Combined sector were 8.53%, 8.65% and 8.60% respectively. The corresponding inflation rates (Final) for Rural, Urban and Combined sector for the month of **August**, 2022 were 7.60%, 7.55% and 7.62% respectively.
- 3. The All-India Index of Industrial Production (IIP) for the month of **August 2022** (Quick Estimates) with the base year 2011-12 has been released on 12th October, 2022 and it stood at 131.3.

As per the latest Review Report on the Performance of the Infrastructure Sectors up to the month of **August 2022**, Power Generation (+12.27%), Coal Production (+9.05%), Refinery Production (+4.70%) and Revenue earning goods Traffic at Railways (+5.33%) and Passenger traffic handled at International terminal of the Airports (+2.86%) exceeded its targets.
- 7. The Sectors that **fell short** of their targets are Fertilizers Production (-13.87%), Crude Oil Production (-3.16%), Natural Gas Production (-2.98%), Upgradation of Highways by NHAI (-9.16%), Upgradation of Highways by State PWD & Border Road Organization(BRO) (-21.46%), Export Cargo handled at Airports (-17.15%) Import Cargo handled at Airports (-14.15%), and Passenger traffic handled at Domestic terminal of the Airports (-8.50%).
