Major initiatives and achievements of the Ministry of Statistics & Programme Implementation for the month of June 2024.

The Ministry released the Publication- 'Statistical Report on Value of Output from Agriculture and Allied Sectors 2024'. The publication is a comprehensive and insightful document which provides detailed tables and analysis of values of output of Agriculture, Livestock, Forestry and Fishing sectors from 2011-12 to 2022-23. This detailed publication comes after the major aggregates at all India level are published in the form of National Accounts Statistics based on the First Revised Estimates (FRE)/ Second Revised Estimates (SRE) (released on February 28th/29th). Key highlights of the Publication are —

- The shares of Crop, Livestock, Forestry and Fishing sub-sectors in value of output of Agriculture and allied sector were 54.3%, 30.9%, 7.9% and 6.9% respectively in 2022-23.
- 2. The Ministry released Price Movement of Sub-Groups/Groups of Consumer Price Index (CPI) on Base 2012=100 for All India Rural, Urban, Combined for the month of June, 2024 (Provisional) and for the month of May, 2024 (Final) on 12th July, 2024. The General Consumer Price Indices (CPI) for the month of June, 2024 (Provisional) for Rural, Urban and Combined sector were 192.2, 187.8 and 190.2 showing an annual inflation rate of 5.66%, 4.39%, 5.08% respectively. The corresponding inflation rates (Final) for Rural, Urban and Combined sector for the month of May, 2024 were 5.34%, 4.21% and 4.80% respectively.
- 3. All-India Consumer Food Price Index (CFPI) for the month of June, 2024 (Provisional) for Rural, Urban and Combined sector were 195.6, 204.2 and 198.7 respectively. All India year-on-year inflation rates for CFPI for the month of June, 2024 (Provisional) for Rural, Urban and Combined sector were 9.15%, 9.55% and 9.36% respectively. The corresponding inflation rates (Final) for Rural, Urban and Combined sector for the month of May, 2024 were 8.62%, 8.83% and 8.69% respectively.
- 4. The All-India Index of Industrial Production (IIP) for the month of May, 2024 (Quick Estimates) with the base year 2011-12 was released on 12th July, 2024 and it stood at 154.2.
- 5. The Ministry also released following publications during the month:
 - (i) Payroll Reporting in India: An Employment Perspective January to April, 2024.
 - (ii) Household Consumption Expenditure Survey 2022-23.
 - (iii) ASUSE 2021-22 & 2022-23 and AYUSH 79th Round, 2022-23.
 - (iv) "EnviStats India 2024: Environment Statistics": Seventh series of the publication titled "EnviStats India 2024: Environment".
- 6. The Ministry organized Statistics Day 2024 on 29.06.2024 (Saturday) with the theme of "Using Data for Decision Making". The event was inaugurated by Dr. Arvind Panagariya, Chairman, 16th Finance Commission and attended by representatives from the Central Government, State/UT Governments, academic institutions and other national and international agencies. The following were also released/launched on this occasion:
- a) SDG publications: (i) Sustainable Development Goals National Indicator Framework Progress Report, 2024 (ii) Data Snapshot on Sustainable Development Goals National Indicator Framework, 2024 (iii) Sustainable Development Goals National Indicator Framework, 2024.

- b) eSankhiyiki portal (https://esankhiyiki.mospi.gov.in) with the objective to establish a comprehensive data management and sharing system for ease of access for use and reuse of official statistics by the users, researchers, Students, policy makers etc.
- 7. The Ministry organized a "Data Users Conference" on the survey results of the Household Consumption Expenditure Survey (HCES) 2022-23 at New Delhi on 19.06.2024 in order to enhance its engagement with data users and stakeholders, fostering valuable feedback and collaboration. It was inaugurated by Dr. Bibek Debroy, Chairman, EAC to PM.
- 8. The major highlights of Central Sector Projects monitored under Online Computerized Monitoring System (OCMS) by this Ministry for the month of **June, 2024:**

As per the latest Review Report on the Performance of the Infrastructure Sectors, the positive growth rate has been observed in April-May FY 24-25 over corresponding month of FY 23-24 across pertinent parameters viz. [Power] Power Generation (+12.03%), [Coal] Coal including Lignite Production (+9.52%), [Steel] Production of Finished Steel (+6%), [Fertilizers] Nitrogen, Phosphate and Urea Production (+0.9%), [Petroleum and Natural Gas] Crude Oil Production (+0.23%), Crude Oil Processed (+1.06%) & Natural Gas Production (+7.24%), [Roads] Upgradation of Highways by State PWD & Border Road Organization (BRO) (+12.04%), [Railways] Passenger Traffic handled (+3.91%) & Revenue earning Freight Traffic (+2.62%), [Shipping] Total Cargo handled at Major Ports (+2.52%), [Civil Aviation] International Passenger traffic handled (+15.65%) & Domestic Passenger traffic handled (+4.91%), [Civil Aviation] Export Cargo handled at Airports (+20.13%) & Import Cargo handled at Airports (+14.4%) and [Telecom] Net new Wire line & Wireless Telephone connections (+974.28%). However, negative growth has been observed across a few parameters viz. [Cement] Cement Production (-0.29%), [Roads] Upgradation of Highways by NHAI (-5.1%), [Shipping] Coal handled at Major Ports (-2.35%), and [Telecom] Towers including Base Transceiver Stations (-77.66%).
