Major initiatives and achievements of the Ministry of Statistics & Programme Implementation during July, 2021

The National Statistical Office (NSO) released Price Movement of Sub-Groups/Groups of Consumer Price Index (CPI) on **Base 2012=100** for All India Rural, Urban, Combined for the month of July 2021 (Provisional) and for the month of June 2021 (Final) on 12th August, 2021.

- 2. The General Consumer Price Indices (CPI) for the month of **July, 2021** (Provisional) for Rural, Urban and Combined were 163.2, 161.8 and 162.5, showing an annual inflation rate of 5.49%, 5.82% and 5.59% respectively. The corresponding inflation rates (Final) for Rural, Urban and Combined for **June, 2021** were 6.16%, 6.37% and 6.26% respectively.
- 3. All-India Consumer Food Price Index (CFPI) for the month of July, 2021 (Provisional) for Rural, Urban and Combined were 160.4, 167.4 and 162.9 respectively. All India year-on-year inflation rates for CFPI for the month of July, 2021 for Rural, Urban and Combined sector were 3.55%, 4.56% and 3.96% respectively. The corresponding inflation rates (Final) for Rural, Urban and Combined for June, 2021 were 5.02%, 5.42% and 5.15% respectively.
- 4. The all-India Index of Industrial Production (IIP) with base 2011-12 for the month of June, 2021 (Quick Estimates) was released on 12th August, 2021 and it stands at 122.6.
- 5. The Ministry released two important publications viz. Annual Report of Periodic Labour Force Survey (PLFS) for the year 2019-20 and "Elderly in India 2021" during the month of July 2021. While the Annual Report on PLFS provides estimates of key employment and unemployment indicators, the report on "Elderly in India 2021" will provide a valuable data source to policy makers and researchers for comprehensive appreciation of elderly population in the country.
- 6. The major highlights of Central Sector Projects costing Rs. 150 crores and above monitored under Online Computerized Monitoring System (OCMS) by this Ministry for the month of July, 2021 are as under:

- 7. As per the latest Review Report on the Performance of the Infrastructure Sectors up to the month of June 2021, Power Generation (+9.15%), Railways (+13.87%) and Import Cargo handled at Airports (+25.77%) exceeded its targets.
- 8. The Infrastructure Sectors that fell short of their targets are Coal Production (-17.80%), Fertilizers Production (-20.16%), Crude Oil Production (-2.24%), Refinery Production (-2.74%)Natural Gas Production (-3.52%), Upgradation of Highways by NHAI (-28.27%), Upgradation of Highways by State PWD & Border Road Organization(BRO) (-19.62%), Export Cargo handled at Airports (-10.12%), Passenger traffic handled at International terminal of the Airports (-0.75%) and Passenger traffic handled at Domestic terminal of the Airports (-3.16%).
