OVERALL PERFORMANCE ANALYSIS

Twenty Point Programme-2006

Progress Report – (April 2018 - September 2018)

1. This progress report of Twenty Point Programme-2006 consists of two parts: **Part-I** contains an analysis of the overall performance, whereas **Part-II** deals with item-wise performance.
2. The report is compiled on the basis of data received from the Central Nodal Ministries and State Governments/UT Administrations. Presently, 16 parameters are taken for quarterly performance analysis. The data are received either through web enabled software developed by National Informatics Centre (NIC) Cell in this Ministry or through fax/e-mail/post.
3. The analysis for the period **April 2018 - September 2018** shows that the performance under **eleven items/parameters** has been ‘**Very Good**’ (90% or above the targets). These items/parameters are:
 - (i) Seedlings planted (Public and Forest Lands)
 - (ii) Pumps sets energized
 - (iii) Area Covered under Plantation (Public and Forest Lands)
 - (iv) Number of SHGs promoted (new and revived) during the financial year - NRLM
 - (v) Rural Housing - PMAY(G)
 - (vi) Food Security: National Food Security Act (Tide Over)-NFSA
 - (vii) ICDS Blocks Operational (Cum.)
 - (viii) Electricity supplied
 - (ix) Anganwadis Functional (Cum.)
 - (x) Food Security: Targeted Public Distribution System (TPDS)
 - (xi) Food Security: National Food Security Act (Normal)-NFSA
4. There is no item/parameter in the category of ‘Good’ (80% or above but less than 90%).
5. The performance of eight items/parameters has been ‘Poor’ (below 80% of target). These items/parameters are:
 - (i) Partially Covered Habitations – NRDWP
 - (ii) Number of SHGs provided Community Investment Fund (CIF) during the financial year - NRLM
 - (iii) Number of SHGs provided Revolving Fund (RF) during the financial year - NRLM
 - (iv) Road constructed- PMGSY
 - (v) Coverage of quality affected habitations - NRDWP
6. Rest of the quarterly monitored items are being monitored without any targets.
