2. Terms of Reference of the Committee

- (i) To standardise concepts, definitions and methodology for compilation of infrastructure statistics.
 - (ii) To define the scope and coverage of infrastructure statistics and suggest changes in the same from time to time.
 - (iii) To suggest improvements in infrastructure statistics in view of international practices, recommendations made by other expert bodies and to satisfy the domestic requirements of planners and policy makers at different levels.
3. The Committee may co-opt any officer(s) or Expert(s) with experience in Industrial Statistics, as may be deemed necessary by it to help it to formulate its views and reports.
4. TA/DA of the official members shall be borne by their respective Ministries/ Departments/ Organisations. The non-official members would be entitled to TA/DA as per rules. The expenditure of the Committee would be borne by the Ministry of Statistics and Programme Implementation under the Head of Account 3454 (Major Head), 02.204 Central Statistical Organisation(Minor Head).
