- 2. Survey Coordination Division (SCD), NSO will handle all work related to designating CPIOs and FAAs for all the field offices under NSS.
- 3. In the event of designated CPIOs/FAAs availing leave or transferred or retired or the post lying vacant for any other reason, the Link Officer or the newly joined officer in place of the earlier one or the chain of officer down the line would act as CPIO/FAA to fulfill the duties bestowed under the RTI Act.
- 4. RTI Cell has already created and conveyed Login IDs and passwords to access RTI MIS portal for every CPIO and First Appellate Authority. RTI applications or First Appeals which are received online through RTI-MIS portal of the Ministry would be forwarded to the concerned CPIOs or FAAs online through RTI-MIS portal only. All the CPIOs and FAAs are again requested to ensure the 'daily monitoring' of their respective account on RTI-MIS portal.
- 5. The new arrangement of CPIOs and FAAs in the MPLADS division being made vide the instant order shall be effective from the date of issue of this order. All the RTI Applications and First Appeals pending prior to the date of issue of this order shall be disposed off by the respective CPIO/ FAA as per the past arrangement.
