**OFFICE ORDER**

2. Other content of the aforesaid Office Order dated 17.04.2023 remains unchanged.

In the event of designated CPIOs/FAAs availing leave or transferred or retired or the post lying vacant for any other reason, the Link Officer or the newly joined officer in place of the earlier one or the chain of officer down the line would act as CPIO/FAA to fulfill the duties bestowed under the RTI Act.


