Director level officers as CPIO and Jt. Director/ Director level officers as FAA under intimation to RTI Cell of the Ministry.
- 3. In the event of designated CPIOs/FAAs availing leave or transferred or retired or the post lying vacant for any other reason, the Link Officer or the newly joined officer in place of the earlier one or the chain of officer down the line would act as CPIO/FAA to fulfill the duties bestowed under the RTI Act.
- 4. All the CPIOs and FAAs are requested to ensure *daily monitoring and timely disposal* of RTI applications/ appeals as well from RTI-MIS portal.
- 5. All the Sections/ Divisions are also requested to *intimate promptly* to the RTI Cell (E-mail: pigr-mospi@mospi.gov.in, Ph: 011-23455613) of the Ministry regarding any change/ updation in the RTI-MIS account of respective CPIOs/FAAs in the Ministry.
