

4. RTI Cell has created Login ID and password to access RTI MIS portal for each CPIO and First Appellate Authority. RTI applications or First Appeals which are received online through RTI-MIS portal of the Ministry would be forwarded to the concerned CPIOs or FAAs online through RTI-MIS portal only. All the CPIOs and FAAs are requested to ensure the '**daily monitoring**' of their respective RTI-MIS portal.
