OFFICE MEMORANDUM

- 1. This has reference in DoPT's advice conveyed with the approval of Cabinet Secretary *vide* their ID Note no. Misc.14017/3/2016-Estt(RR)(1114384) dated 01.03.2016.
- 2. The following has been decided in MoSPI:
 - A. i. The ISS and SSS posts of erstwhile Planning Commission that have been surrendered by NITI Aayog have been taken on record in MoSPI.
 - ii. MoSPI will **not** post any officer to NITI Aayog against these surrendered posts.
 - iii. Subsequent deployment of ISS/SSS officers under CSS/on deputation to NITI Aayog cannot be ensured by MoSPI in the normal course.
 - B. i. Posts retained by NITI Aayog [7 in number; 3 of ISS (1 of STS and 2 of JTS) and 4 of SSS (2 of SSOs and 2 of JSOs)] will be treated by MoSPI as en-cadred posts of ISS and SSS in NITI Aayog.
 - ii. MoSPI will **not** post any ISS or SSS officer to NITI Aayog over and above this en-cadred strength of 3 and 4 respectively.
 - iii. Ms. E. Renbi Jami, who has been promoted to STS and transferred to NSSO (DPD), Kolkata will be relieved by NITI Aayog. A suitable replacement at the level of JTS, after consideration by CSB, and after competent approval in MoSPI, will be provided to NITI Aayog by MoSPI in the normal course [at par with the level of the post retained by NITI Aayog (JTS level)].
 - iv. Orders of direct deputation of 12 ISS/SSS officers (as advised by Cabinet Secretariat) for a period of 3 years from the date of creation of NITI Aayog (01st January 2015) or until further orders or till their dates of superannuation, whichever is earliest, as a one-time

exercise have been issued by MoSPI vide Order of even number dated 11.04.2016.

[Future requests, if any, from NITI Aayog for officers on direct deputation will be considered **on merit** by MoSPI as per its **internal laid-down mechanisms**. MoSPI does **not** commit itself to provide officers on direct deputation. (This was also informed to NITI Aayog vide ID Note of even no. dated 17.08.2015.)]

- v. Transfer order no. 12016/10(JTS)/2012-ISS dated 18.09.2014 in respect of Shri Vibeesh E.M. (who was not relieved by erstwhile Planning Commission/NITI Aayog and who has now been retained on direct deputation in NITI Aayog) has been cancelled by MoSPI vide Order of even no. dated 11.04.2016.
- 3. This has the approval of Hon'ble Minister for Ministry of Statistics and Programme Implementation.
