**ORDER**

**Subject: Grant of Assured Career Progression (ACP) to SI Grade I of SSS - Regarding.**

In pursuance of DOP&T OM No. 35034/1/ 97 – Estt. (D) dated 9<sup>th</sup> August 1999 and this Ministry OM No. 11024 / 12 / 2013 – SSS dated 30<sup>th</sup> January 2014 demarcating guidelines to regularize ACP in SSS and on the recommendation of the Screening Committee Meeting dated 12<sup>th</sup> March 2014, the Competent Authority has approved grant of 1<sup>st</sup> and 2<sup>nd</sup> **ACP** in the pay scale of **Rs. 8000-13500**, on personal basis to Statistical Investigator Grade I who were in the pay scale of **Rs. 6500 – 10500** of Subordinate Statistical Service (SSS) and were eligible for 1<sup>st</sup> or 2<sup>nd</sup> **ACP** on completion of **12 / 24** years of regular service **after 12<sup>th</sup> February 2002** as per details given below:


condition of ACP from the service records of the officers. Earlier order for 1<sup>st</sup> and 2<sup>nd</sup> ACP in respect of above officials in the pay scale of Rs. 7450 -11500 (NFSG) may be treated as cancelled.

4. The Participating Ministries / Departments / Organizations of SSS are requested to ensure that officer placed in the higher Pay Scale under ACP, was not under suspension or no charge sheet was issued or no disciplinary proceeding or prosecution case for criminal charge was pending against him on the crucial date.

5. The officer, who is under currency of penalty, if any, will be placed in the next higher Pay as per ACP Scheme only on expiry of that period.

6. Revised MACP orders would be issued by the cadre separately for the above SSS incumbents in the light of MACP guidelines.

7. The Participating Ministries / Departments / Organizations of SSS are requested to provide copy of this order to all concerned incumbents and place a copy of the same in the service book of the officials.


