The undersigned is directed to refer to Directorate General of Civil Aviation's Order No.A-19011/12/2011-E.II dated 18.04.2016 on the above subject wherein Pay of Sh. B.P. Majhi has been refixed w.e.f. 11.02.1991 by giving the benefit of Judgment dated 11.05.2010 of the Hon'ble Supreme Court of India in SLP(C) No.6784/2004 converted to Civil Appeal No.8273/2004- Union of India & Others Vs B. Anil Kumar & Others regarding Special Pay of Rs.75/- to Assistant Superintedents.

- It has been observed that pay of Sh. B.P. Manjhi has not been re-fixed as per this Ministry's instructions issued vide O.M. No. No.C-18013/11/2002-Ad.III (Vol.II) dated 08.10.2013(copy enclosed) wherein clarification regarding the manner / modalities of implementation of the Judgment dated 11.05.2010 has been issued.
- 3. According to para 5 of this Minsitry's aforesaid O.M. dated 08.10.2013, Special Pay of Rs.75/only is admissible to Assistant Superintendents promoted after 01.01.1986 and Special Pay of Rs.75 would not be taken into consideration for benefits like DA and other allowances(which are admissible on Basic Pay only) and moreover Special Pay of Rs.75 would only be admissible (not double).
- Directorate of Civl Aviation is, therefore, adviced to re-fix the pay of Sh. B.P. Manjhi as per para 5 4. of this Ministry's aforesaid O.M. dated 08.10.2013.



Sub: Implementation of Judgment dated 11.05.2010 of the Hon'ble Supreme Court of India in SLP(c) 6784/2004 converted to Civil Appeal No. 8273/2004 – Union of India & Others Vs. B. Anil Kumar & Others reg. extending benefit of Rs. 75/- as Special Pay.

The undersigned is directed to refer to this Ministry's letters of even no. dated 29-06-2011 and 26-09-2012 directing that the judgement order of the Supreme Court dated 11-05-2010 and 13-04-2010 be implemented in respect of the applicants and the applicants for intervention as well as in respect of the similarly placed/circumstanced non-applicants.

- 2. This Ministry received queries from FOD for clarification regarding the manner/ modalities of implementation of the judgement dated 11-05-2010 and the implication of para 14 of the judgement.
- **3.** The following facts are relevant:
- (i) In CCS (Revised Pay) Rules 1986, Basic Pay is defined to mean Pay as defined in FR 9 (21) (a) (i) which defines Pay as the Pay other than Special Pay or Pay granted in view of personal qualification which has been sanctioned for a post held substantively or in officiating capacity or to which entitled by reason of position in a cadre.
- (ii) It is therefore clear that Special Pay is distinct and separate from Basic Pay and is not part of Basic Pay after 01-01-1986 i.e. after coming into vogue of CCS (RP) Rules 1986.
- (iii) As per normal administrative and financial practice DA and other allowances are paid only on Basic Pay.
- (iv) Assistant Superintendents promoted prior to 01-01-1986 have already been given benefit of Special Pay of Rs.75 in the pre-revised Pay Scale of Rs.475-750 and their pay in the revised Pay Scale of Rs.1600-2600 had been fixed after taking into consideration Special Pay of Rs.75. Giving

them Special Pay again would be tantamount to double benefit of Special Pay.

- (v) The normal replacement scale of pay of Rs.450-750 of Assistant Superintendents as per the Fourth Central Pay Commission was Rs.1400-2600. As against this normal replacement scale, Assistant Superintendents were granted a higher replacement scale of Rs.1600-2600 after taking into account their duties and responsibilities. Therefore the need for grant of Special Pay was adequately taken care of.
- 4. The matter of implication of para 14 of the judgement dated 11-05-2010 and manner / modalities of implementation is under examination. When a final decision in the matter is taken, in consultation with Ministry of Law, Department of Expenditure and DoPT, the same would also be communicated to FOD and concerned Ministries / Departments.
- 5. Meanwhile, inter alia considering the facts mentioned in para 3 above, the implementation of the judgement dated 11.05.2010 would be appropriate and logical in the following manner:
- (a) Assistant Superintendents promoted prior to 01-01-1986 would not be entitled to Special Pay of Rs.75 after 01-01-1986.
- (b) Assistant Superintendents promoted after 01-01-1986 would be entitled to Special Pay of Rs.75 in the revised Pay Scale of Rs.1600-2600.
- (c) Special Pay of Rs.75 would not be taken into consideration for benefits like DA and other allowances (which are admissible on Basic Pay only).
- (d) Special Pay of Rs.75 would be admissible upto 31-12-1995 i.e. the duration of the Fourth Central Pay Commission scales of pay.
- (e) Special Pay of Rs.75 would be admissible (not double).
- 6. However, as stated earlier, the various issues are under examination in consultation with DoPT, MoLaw and DoExpenditure. When a final decision is taken, the same would become applicable.
- 7. Meanwhile, to avoid legal problems and/ or financial impropriety, the judgement dated 11.05.2010 may be implemented on the lines as mentioned in para 5 above.
