 - (i) No officer is unduly harassed by these false and mischievous complaints;
 - (ii) The culpability for administrative misconduct in making false and mischievous complaints, as already directed by Secretary, MoSPI, may not be compromised;

In addition to the above, the above Officials who have made these false and mischievous complaints shall **not** be considered for own-cost transfers up to **31.03.2016**, under any circumstances, except: **(a)** on administrative grounds or reasons; and **(b)** on **genuine established humanitarian grounds** like illness of mother, father, spouse, child or self, supported by a *bona-fide* medical certificate.
