**02.** The grant of financial upgradation is purely personal to the officers and have no relevance to their seniority position. The officers are entitled to exercise their option as per existing instructions of DoP&T for fixation of pay in the light of CCS (Revised Pay) Rules, 2016 and MACP guidelines.

**03.** The participating Ministries / Departments / Organizations of SSS, before fixing pay of the above officers, shall ensure due verification of service particulars and eligibility conditions (i.e. name, post, pay scale on DR basis, date of joining, length of qualifying service etc.) from the service books. They shall also ensure that the officers are clear from vigilance angle, i.e. they are not under suspension and no disciplinary/ criminal case is pending/contemplated against them.

**04.** The grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

**05.** The concerned Head of Departments are requested to ensure that the official concerned has not refused regular promotion(s) before entitled to a financial upgradation in accordance with provisions contained in Annexure of DoP&T OM dated 22.10.2019.
