Office Memorandum

Subject: Online submission of Immovable Property Return (IPR) of officers of Subordinate Statistical Service (SSS) for the year 2020 (as on 01.01.2021) - reg.

The undersigned is directed to invite attention of all the SSS officers to the Rule 18 of the CCS Conduct rule, 1964, which stipulates that every member of the service shall submit her/his **Immovable Property Return (IPR) in the prescribed form by 31st January of every year in respect of the previous year ending 31st December**. Non-submission of IPR within the stipulated time period/date leads to the denial of vigilance clearance to the officers for deputation, cadre clearance etc. Further, non-submission of IPR within stipulated date may invite appropriate disciplinary proceedings in terms of CVC Office Order No.17/11/2020 dated 23.11.2020.

2. As has been decided earlier, it is reiterated that SSS officers are required to **file the Immovable Property Return online on SPARROW platform only**. Necessary instructions in this regard have already been issued vide Ministry's O.Ms, O.M. No. 12021/1/2016-SSS dated 28.12.2017 and dated 04.12.2018.

3. Participating Ministries/Departments /Organisations may kindly ensure that NIC mail ID in respect of all newly joined Junior Statistical Officers(JSOs) through CGLE-2017 are created, so that the Immovable Property Return for the year 2020 are filed online by the incumbents within stipulated period prescribed for the same.

4. The Immovable Property Return for the year 2020 is required to be filed online on SPARROW platform only from 01st January 2021 and latest by 31st January 2021 and the Participating Ministries/Departments /Organisations are requested to circulate the same

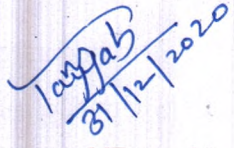

amongst the SSS officers for strict compliance. Immovable Property Return in any form, other than online on SPARROW platform, shall not be accepted.
