The SSOs of SSS are treated equivalent to the Section Officers (SOs) of CSS. Therefore, the reimbursement in respect of newspapers purchased/supplied at their residence; briefcase/office-bag/ladies-purse supplied/purchased for official use and also on providing hospitality in official meetings by them may be made equivalent to that of the SOs of CSS.
