Sub: Absorption of Investigator Grade II of Labour Bureau and Statistical Assistant of Department of posts in Subordinate Statistical Service (SSS)- Regarding.

In pursuance to the directions of Hon'ble High Court of Delhi in Cont. CAS (C) No. 375 / 2017 [Dr. Reji B Vs. Dr. T.C.A Anant] in WP No. 8437 / 2014 dated 30.05.2017, the issue relating to en-cadrement and absorption of Investigator Grade II [29 Posts] of Labour Bureau and Statistical Assistant [4 Posts] of Department of Posts in Subordinate Statistical Service (SSS) has been re-examined in consultation with Department of Personnel & Training (DoPT) and Ministry of Labour & Employment (MoLE) and it has been decided that the concerned officers may be given a final opportunity to opt either to continue in Subordinate Statistical Service (SSS) or opt out of it. The fate of the officers concerned and their entitlements may be decided accordingly.

02. Accordingly, concerned incumbents are hereby given a final opportunity to exercise their revised option to either continue in Subordinate Statistical Service (SSS) based on the existing seniority position, assigned to them in the cadre of Statistical Investigator in Grade IV (Rs.5000 - 8000, Group C and GP of Rs.4200 in 6th CPC) [Re-designated as JSO vide RRs dated 31.05.2013] or opt out from Subordinate Statistical Service (SSS). Those who opt to continue in SSS, shall furnish an unconditional revised <u>option</u> as per the enclosed proforma [Attached as Annex-I], so that their continuation in SSS or otherwise, as the case may be, could be decided.

03. Ministry of Labour & Employment (MoLE), CSO and NSSO (FOD) are requested to provide the option form to the concerned incumbents, as per the list enclosed, with the request to exercise their option within 15 days, if they so desire. If this Ministry does not receive the option within 15 days from the date of issue of this OM, it will be presumed that the concerned incumbents are not willing to continue in SSS.
