**OFFICE MEMORANDUM**

**Subject: Pay fixation on promotion of SSS incumbents after getting MACP- Regarding.**


The undersigned is directed to refer to this Ministry's OM of even number dated 20<sup>th</sup> April 2011 (Copy enclosed) wherein it was clarified that 3% pay fixation benefit is allowed to those incumbents of SSS, who have been granted 1<sup>st</sup>, 2<sup>nd</sup> or 3<sup>rd</sup> MACP in the GP of Rs.4800 and Rs.5400 (PB-2) and subsequently they were promoted as Assistant Director (JTS of ISS) in the GP of Rs.5400 (PB-3). Subsequently, the OM of even No. dated 20<sup>th</sup> April 2011 was withdrawn with retrospective effect vide this Ministry order of even No. dated 6<sup>th</sup> January 2014 (Copy enclosed) with all consequential benefits.

**02.** As a result of above, a large numbers of references have been received from the concerned officials and their Administrative Ministries seeking clarification from the CCA of SSS that whether provisions contained in the OM dated 06.01.2014 would also be applicable in respect of those officials, who have retired / Expired / Vol. Retired before the issuance of OM dated 06.01.2014.

**03.** The above issue has been re-examined in consultation with DOP&T and Ministry of Finance and it has now been decided that as per provisions contained in OM of even number dated 06.01.2014, overpayment made due to wrongful pay fixation has to be withdrawn. Since, recovery has already been effected in case of those officials, who have retired after 06.01.2014, officials retired / expired / vol. retired before 06.01.2014 could not be treated differently. Moreover, as per DOP&T OM No. 18 / 26 / 2011 – Estt. (Pay-I) dated 6<sup>th</sup> February 2014, any wrongful / excess payments made are to be recovered from retrospective effect with all consequential benefits.

**04.** Apart from above, all the concerned officials have been extended 2<sup>nd</sup> ACP in the pay scale of Rs.8000-13500 (GP of Rs.5400, PB-3) during the period of 01.01.2006 to 31.08.2008 vide this Ministry order dated 14.10.2015, 18.12.2015 and 10.02.2016. Further, these officials have also been extended 3<sup>rd</sup> MACP in GP of Rs.6600, PB-3 on completion of 30 years of service on or after 01.09.2008 vide orders dated 14.10.2015, 18.12.2015 and 10.02.2016. In these orders, all concerned participating Ministries of SSS has already been directed that "the 3% pay fixation benefits extended on account of Ad-hoc promotions to JTS of ISS vide this Ministry OM No. 12039 /01 /2013 – SSS dated 20<sup>th</sup> April 2011 may be recovered with all consequential benefits in the light of subsequent OM No. 12039 / 01 / 2013 – SSS dated 6<sup>th</sup> January 2014, if any, before extending the financial benefits under and 2<sup>nd</sup> or 3<sup>rd</sup> MACP, so that excess payment, if any, may be adjusted before settling the arrears".

**Subject: Pay fixation on promotion of SSS incumbents after getting MACP–  
Regarding. ✓**

The undersigned is directed to refer to this Ministry's OM of even number dated 20<sup>th</sup> April 2011 vide which it was clarified that 3% pay fixation benefit is allowed to those incumbents of SSS, who have been granted 1<sup>st</sup>, 2<sup>nd</sup> or 3<sup>rd</sup> MACP in the GP of Rs. 4800 and Rs. 5400 (PB-2) and subsequently they were promoted as Assistant Director (JTS of ISS) in the GP of Rs. 5400 (PB-3).

2. The above issue has been re-examined in consultation with DOP&T and Ministry of Finance and it has now been decided that:

- (i) The OM of even number dated 20<sup>th</sup> April 2011 (**Copy enclosed**) stands withdrawn with retrospective effect from the date of issue and the benefit of 3% pay fixation shall not be admissible, on account of promotion as JTS of ISS in GP of Rs. 5400 (PB-3), even on change of Pay Band, in the light of condition 4 of MACP Scheme. However, only the difference of GP, if any, shall be payable.
- (ii) The excess payment, already made shall be recovered from the concerned incumbents in three equal monthly installments. In case an official is going to superannuate earlier, the duration of recovery may be reduced accordingly. However, it may be ensured that the excess payment, in any case, has to be recovered before his superannuation.

3. All participating Ministries / Departments / Organizations are requested to take immediate action to re-fix the pay of the concerned incumbents under intimation to this Ministry.

Office Memorandum

Sub: Pay fixation on promotion after MACP of SSS incumbents - regarding.

The undersigned is directed to say that a point was raised whether an employee who has been granted 3<sup>rd</sup> MACP on completion of 30 years of service in the Grade pay of Rs. 5400 under Pay Band -2 and subsequently promoted to the post of JTS of ISS under Pay Band -3 in the Grade Pay of Rs. 5400 is further eligible for 3 % pay fixation benefits. This issue was referred to DOP&T and it has been clarified by DOP&T that in view of sub-para (i) of para 13 of 6<sup>th</sup> CPC Notification dated 29<sup>th</sup> August 2008 the benefit of one increment equal to 3% shall be admissible at the time of pay fixation on promotion in higher pay band viz PB-2 to PB -3 (Grade Pay of Rs. 5400/-). However, no difference of Grade Pay would be admissible at this stage as there is no difference in the grade pay of lower and higher pay bands. In view of this all participating Ministries / Departments / Organisations of SSS are requested to fix the pay of concerned officials accordingly.
