Subject: Pending APARs of Junior Statistical Officers of Subordinate Statistical Service (SSS) – Regarding.

Reference is invited to DoPT OM No. 21011 / 02 / 2009 – Estt. (A) Dated 16th February 2009 and subsequent OM No. A- 46030 / 26 /2015 – Ad. I dated 07.10.2015, OM No. 12011 / 02 / 2015 – APAR dated 31.08.2016, OM No. 12011 / 13 / 2016 – APAR dated 26.09.2016 of this Ministry *vide* which it was directed to all the Ministries to strictly follow prescribed time schedule at various stages in the matter of APARs of all classes of employees for smooth consideration of Promotion, MACP, Confirmation, Deputation to ex-cadre posts etc. However, it has been noticed that these instructions of DoPT and MoSPI are not being followed in true letter and spirit. Despite repeated instructions, APARs of the following officers of SSS, of the years as mentioned against their names, have not yet been received in the Ministry:


