Subject: Recovery of excess payments made to the applicant in OA No.2304/06, OA No.109/07, OA No. 646/07, OA No.2132/08, OA No.2186/08, OA No.2645/08, MA No.1558/08, OA No.35/09 and CP(c) No.400/11 in OA No.2131/08, MA No.1006/2011 and O.A. No.2907/2014-Regarding.

The undersigned is directed to refer to the subject mentioned above and to state that the issue of pay fixation in respect of the incumbents absorbed and appointed as Statistical Investigators Grade-I of SSS in the pay scale of ₹7,450-225-11,500 (NFSG) under FR 22 (1) (a) (ii) w.e.f. 1st April 2004 was under consideration of this Ministry. Several notices vide this Ministry's OM of even number dated 05.12.2007; 18.12.2007, 29.08.2008 and OM No.11024/18/2008-SSS dated 10.10.2008 and Order No.11024/26/ 2006-SSS dated 28.03.2011 and vide OM of even number dated 05.06.2014 were served upon the applicants in the light of the above mentioned OA/MAs, etc.

2. As per the decision of Government of India issued vide DoP&T O.M. No.18/26/2011-Estt(Pay-I) dated 6th February 2014, this Ministry in supersession to OM No.11024/26/2006-SSS dated 20.4.2011 decided, with the concurrence of AS&FA to fix the pay of applicants of above mentioned OAs, on account of their absorption and appointment as Statistical Investigators Grade-I (NFSG) of SSS, in the pay scale of ₹7,450-225-11,500 under FR22(1)(a)(ii) w.e.f. 1st April 2004 and to recover excess payment made to the concerned officers of SSS.

3. In pursuance to Hon'ble CAT (PB), New Delhi Order dated 05.09.2014 in the O.A. No.2907/2014 (Shri Ravi Velivel V/s. UOI), the applicant may once again be afforded an opportunity to submit his representation, if any, within 15 days of receipt of this OM to show cause why the proposed recovery of excess payment not be made from him due to wrong fixation of his pay in the pay scale of ₹7,450-225-11,500 (NFSG) under FR22(1) (a)(ii) w.e.f. 1st April 2004 on account of their absorption and appointment as Statistical Investigators Grade-I (NFSG) of SSS, specifically when no relief has been granted to the applicant by Hon'ble Court as regards fixation of his pay under FR22(1)(a)(i), in any of the aforementioned court cases.

4. If no representation is received from him within the stipulated period of 15 days, it would be deemed that the incumbent has nothing to represent and the excess payment made, if any, shall be recovered from him in ten equal monthly installments.

5. The Office of the Chief Labour Commissioner (Central), Ministry of Labour & Employment, New Delhi is, therefore, requested to take immediate action to bring it to the notice of the applicant working under their administrative control with proper acknowledgement and forward his representation, if any, to this Ministry for appropriate action.

6. This issues with the approval of the competent authority.
