^{2.} The transfers of aforementioned SSS officers are on their own requests and these officers shall not be entitled for any joining time/TA/DA etc. However, as per clause 4.2 of Transfer and Placement Policy for officers of the Subordinate Statistical Service (SSS) no. 11024/26(01)/2015-SSS dated 03.10.2023, those officers who have completed 04 (four) years or more at the present place of posting (from the date of joining at present place of posting to till the date of issuance of the transfer order) shall be entitled for TA/DA/Joining time etc. as per extant rules.

- 3. The officers mentioned at SI. no. 12 & sl. No. 61 in above table are under posting in SSS since 13.05.2024 & 31.05.2024 respectively and their period in SSS Cadre till 21.06.2024 be treated as 'compulsory wait' period. The salary and other allowances admissible to the officers, for the compulsory wait period in the Cadre, be paid by their new office. The officers shall be entitled for TA/DA/Joining time etc. as per extant rules.
- 4. The concerned Departments/Ministries are requested to relieve the officers immediately so as to enable them to join at their respective new place of posting.
- 5. Also, the JSOs of SSS officers transferred & posted by this Ministry *vide* earlier orders dated 21.04.2023, 24.11.2023, 01.02.2024, 26.03.2024, 23.04.2024 and who haven't yet joined their new place of posting, hereby stand relieved *w.e.f.* 28.06.2024 with the directions to join their new place of postings.
