

2. The transfers of aforementioned SSS officers are on own requests and these officers shall not be entitled for any joining time/TA/DA etc. However, as per clause 4.2 of Transfer and Placement Policy for officers of the Subordinate Statistical Service (SSS) no. 11024/26(01)/2015-SSS dated 03.10.2023, those officers who have completed 04 (four) years or more at the present place of posting (from the date of joining at present place of posting to till the date of issuance of the transfer order) shall be entitled for TA/DA/Joining time etc. as per extant rules.

3. The officer mentioned at Sl. no. 6 in above table is under posting in SSS since 13.02.2024 and the period from 13.02.2024 to 26.03.2024 be treated as 'compulsory wait' in SSS Cadre. The salary and other allowances admissible to the officer, for the compulsory wait period in the Cadre, be paid by his new office i.e., NSSO (FOD) RO Mumbai. The officer shall be entitled for TA/DA/Joining time etc. as per extant rules.

4. The concerned Departments/Ministries are requested to relieve the officers immediately so as to enable them to join at their respective new place of posting.

5. However, in view of declaration of election to the Lok Sabha, the Model Code of Conduct for General Election -2024 is in force. Therefore, if the transferred officers are on election duty or likely to be on election related duty (if their names have been sent for election duty), the officers may kindly be relieved only after completion of their election duty.
