Subject:- Preferences for posting--seeking preference from SSOs of SSS--regarding.


The undersigned is directed to refer to Para 4.1 of the Transfer and Placement Policy for officers of the Subordinate Statistical Service (SSS), dated 03.10.2023, vide which the minimum and maximum tenure of service for Senior Statistical Officer (SSO) at one station has been prescribed as below:-

| Designation | Maximum Tenure (In Years) | Minimum Tenure (In Years) |

| Senior Statistical Officer(SSO) | 7 | 3 |

2. Accordingly, all Senior Statistical Officers (Level-7) of SSS, who will be completing 6.5 years or more on 31-3-2024, in one level at one station (including Delhi) are hereby requested to convey their preferences for posting in the format annexed herewith, **latest by 31.03.2024**. Any request received after 31st March, 2024 shall not be entertained.

3. It may be noted that seeking posting preferences for transfer **does not confer any right** in favour of the officer for posting.


4. Further, attention is invited to the instructions issued vide Ministry's OM dated 14.09.2015, 11.12.2017, 07.07.2020 (copy enclosed) and DoPT OM dated 31.08.2015 which states that officers shall not bring in any outside influence regarding their service matters. Further, it is to inform that the representation by relatives of Government Servant is also treated as outside influence as clarified vide MHA O.M. dated 19.09.1963. If such influence from extraneous source in favour of

an officer is received, it will be presumed that the same has been brought in consciously and knowingly by the officer and will be viewed adversely and the officer will be liable for disciplinary action as per under the CCS(Conduct) Rules, 1964.
